The AGC of Mississippi was chartered by the AGC of America in April of 1946. The Association merged with the Mississippi Gulf Coast Chapter and became a state-wide organization in 1972. ## **DUES AND JOB FEES SCHEDULE**

### **GENERAL CONTRACTOR MEMBERS**

\$1,000 per year dues plus job fees based on 1/5 of 1% (.002) of awarded contracts. The minimum job fees are \$1,500 per year and the max is \$7,500.

### **PROVISIONAL MEMBERS**

New general contractor members to AGC are allowed to participate as provisional members for their first three years of membership. Dues are \$500 per year plus minimum job fees of \$750 per year for 3 years. The maximum job fee is \$7,500 based on 1/5 of 1% (.002) of awarded contracts.

### **EMERGING MEMBERS**

Emerging Contractor Members are those members in business 1 to 3 years. Dues are \$500 per year for 3 years and job fees are \$750 per year for 3 years. Emerging Subcontractors pay no job fees.

### **UTILITY INFRASTRUCTURE MEMBERS**

\$1,000 per year dues plus annual job fees of \$1,050.

### **ASSOCIATE MEMBERS (AGC OR UI)**

**(SUBCONTRACTORS, ROAD/BRIDGE, MATERIAL SUPPLIERS OR SERVICE COMPANIES)**

\$950 per year dues-no job fees are assessed.

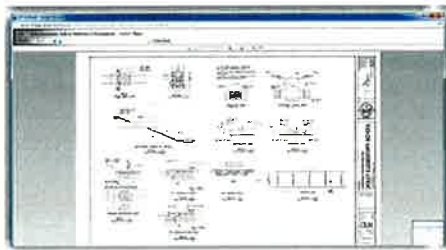
